ORDER:

The Government is in the process of creating a new institution, the Economic Development Board (EDB), whose principal mandate would be to facilitate and effectively manage the strategic planning, resource mobilisation, investment facilitation, public-private partnership project prioritisation and coordination, large project monitoring and setting up special purpose vehicles for accelerated economic development in the State.

2. The Economic Development Board will facilitate integration of industrial development with infrastructure and human capital development while proactively leveraging and promoting appropriate technologies, innovations across the entire spectrum of the projects. The Board, working closely and in tandem with the departments and the entities under their control to improve the overall investment climate and strengthen investor confidence, substantially improve the ease of doing business, mobilise the resources required for supplementing public and private investment and assist the Government in setting up special purpose vehicles (SPVs) for focused development outcomes.

3. Overall, the Economic Development Board will be responsible for driving the accelerated economic development of the State, working in close coordination and collaboration with the government, private sector, research and knowledge centres, financial institutions, from across the globe. The Board will provide strategic leadership, guidance and supervision for the development and effective execution of integrated and comprehensive policies and programmes essential for the accelerated development that would enable the State to translate its vision reality.

4. Government decided to appoint a professional in developmental policy, planning and implementation as Consultant, Economic Development Board Operations for a period of one year. Considering the outstanding academic record and extraordinary work being done by Sri RajendraKondepati as Prime Minister's Fellow and his critical involvement with the conceptualization in setting up of Economic Development Board and its Summer Fellowship Programme, to support the establishment of Economic Development Board and accordingly order that his services be engaged on contract basis with effect from 25th June 2015 as Consultant, Economic Development Board Operations in Finance Department for a period of one year or such time he is reassigned to Economic Development Board, whichever is earlier with a consultancy fee of Rs.1.25 lakh per month with vehicle and mobile, TA and DA as per rules in vogue.
