**NOTIFICATION**

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and of all other powers hereunto enabling, the Governor of Andhra Pradesh hereby makes the following special rules for the Andhra Pradesh Electrical Inspectorate Service in supersession of Special Adhoc Rules issued in G.O.Ms.No.791, P.W.D. Dated 8-5-1967, G.O.Ms.No.1552, P.W.D. Dated 4-12-1972 and G. O .Ms. No. 691 P.W.D. Dated 19-7-1974.

**RULES**

**1.SHORT TITLE:**

(1) These rules may be called the Andhra Pradesh Electrical  
Inspectorate Service Rules.

**2. Constitution:**

The service shall consist of the following categories of posts  
in the Andhra Pradesh Electrical Inspectorate Services:-

**CLASS-A**

Category (1)	...	Chief Electrical Inspector.
Category (2)	...	Deputy Chief Electrical Inspector.
Category (3)	...	Electrical Inspector.
Category (4)	...	Assistant Electrical Inspector.
Category (5)	...	Junior Engineer.

**CLASS-B**

Category (1)	...	Accounts Officer
Category (2)	...	Assistant Accounts Officer.

### **3. Method of appointment:**

Subject to the other provisions in these rules, the method of appointment for the several categories of Posts shall be as follows:-

Category (1)	Method of appointment (2)
<b><u>CLASS-A:</u></b>	
1. Chief Electrical Inspector	By Promotion from category 2 of Class –A.
2. Deputy Chief Electrical Inspector.	By Promotion from Category 3 of Class –A.
3. Electrical Inspector.	By Promotion from category 4 of Class-A.
4. Assistant Electrical Inspector.	By Promotion from Category 5 of Class-A.
5. Junior Engineer.	(i) By direct recruitment. (ii) By appointment by transfer to Tester in Andhra Pradesh Electrical Inspectorate Sub-ordinate Service.

### **CLASS-B**

1. Accounts Officer.	By promotion from Category 2 of Class-B.
2. Assistant Accounts Officer.	(i) By appointment by transfer of Superintendent in Andhra Pradesh Ministerial Service In the Electrical Inspectorate Department. (ii) By direct recruitment in the event of non-availability of Candidates by appointment by transfer.

**NOTE:** Appointment to the post of Junior Engineer by transfer from the Category of Tester shall be made against the tenth vacancy in a unit of ten vacancies. If a qualified Tester is not available, the vacancy shall be filled in by direct recruitment.

### **4. Reservation of appointments:**

(1) In the matter of direct recruitment to posts for which women and men are equally suited other things being equal, preference shall be given to women and they shall be selected to an extent of at least 30% of posts in each category of OC, BC, SC & ST quota, provided that if sufficient number of women candidates are not available, such vacancies may be filled by men candidates.

(2) General Rule 22 of Andhra Pradesh State & Sub-Ordinate Services Rules will apply for direct recruitment posts excluding reservations to Physically Handicapped Persons.

**5. Qualification:**

No Person shall be eligible for appointment to the categories specified in column (1) or the annexure to these rules by the method specified in column (2), unless he possesses the qualifications specified in the corresponding entry in column (3) thereof.

**6. Age:**

No person shall be eligible for appointment by direct recruitment, if he/ she has completed 28 Years of age on the first day of July of the year in which the notification for selection is made.

**7. Minimum Service:**

No person shall be eligible for appointment by transfer or promotion unless he has put in not less than three years of service after the category from which promotion or appointment by transfer is made.

**8. Probation:**

Every person appointed by direct recruitment shall be on probation for a total period of two years on duty within a continuous period of three years and every person appointed to any of the posts either by promotion or by transfer shall be on probation for a total period of one year on duty within a continuous period of two years, From the date on which he commences his probation.

**9. Tests:**

Every person appointed by direct recruitment shall pass the following tests within the period of Probation:

- (i) Accounts Test for Executive Officers.
- (ii) Departmental Test of the Electrical Inspectorate.

(ii) Must have three years Practical experience in Electrical Engineering of which not less than One year shall be in the field of Electrical and Mechanical work shop or in generation or distribution of Electricity or in the administration of Indian Electricity Act. 1910 and the rules made there under.

2. Assistant Accounts Officer.	By direct Recruitment.  By appointment	Must Possess a Bachelor's Degree of a University in India established or incorporated by or under a Central Act or a State Act or a Provincial Act or by an Institution recognised by the University Grants Commission. 1) Must possess a Bachelor's Degree of University in India established or incorporated by or a State Act or a Provincial Act or by an Institution recognized by the University Grants Commission 2) Must have passed Departmental Test for Electrical Inspectorate.
