ORDER:

The Government have appointed the One Man Commission to take up comprehensive examination, vision and updating of the Service Rules for the various posts under the state Government. Accordingly the One Man Commission took up the Special Rules for and Andhra Pradesh Police (Computer Centre) Service of the Police Department among others. The One Man Commission after detailed discussions with all concerned, prepared, the draft rules governing the Gazetted posts in the Andhra Pradesh Police (Computer Centre) Service and forwarded them to Government for approval and issue.

2. The Government after careful examination of the draft rules prepared by the One Man Commission for Andhra Pradesh Police (Computer Centre) service issue the following Special Rules for the Andhra Pradesh Police (Computer Centre) Service.

3. The following notification shall be published in the Andhra Pradesh Gazette:-

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India and of all other power hereunto enabling, the Governor of Andhra Pradesh and in super session of the Special and Andhra Rules issued in G.O.Ms.No.206, Home Department, dated 28th March, 1980 in respect of E.D.P. Manager and G.O.Ms.No.349, Home Department, dt.26.5.1984 in respect of Console Operator as amended from time to time. Hereby makes the following Special Rules for the Andhra Pradesh (Computer Centre) Service:-

RULES

1.Short title:

These rules may be called the Andhra Pradesh Police (Computer Centre) Service Rules.

1. Constitution.

The service shall consists of the following categories of posts in the Andhra Pradesh Police (Computer Centre) service:-

CLASS-A.

- Category (1) : Joint Director (in the Rank of Senior Superintendent of Police) (Cadre/Non-Cadre)
Category (2) Deputy Director (in the rank of Additional Superintendent of Police (Non -Cadre)
Category (3) Deputy Superintendent of Police
Category(4) Inspector of Police

CLASS -B

- Category (1) System Analyst
Category (2) Associate Systems Analyst
Category (3) Programmer.

3. Method of Appointment:

Subject to the other provisions in these rules, the method of appointment for the several categories shall be as follows:-

Class & Category	Method of Appointment
CLASS -A:	
1. Joint Director Superintendent of Police	By transfer on tenure basis of officers in equivalent ranks in other wings of police Department preferably these qualified in Computer Technology or having knowledge of Computer applications.
2. Deputy Director Additional Superintendent of Police	
3. Deputy Superintendent of Police	
4. Inspector of Police	
Class -B	
1. Systems Analyst	(i) By promotion from the post of Associate Systems Analyst. (ii) By transfer on tenure basis of persons in equivalent or comparable rank in any department of State Government or a State Government undertaking inclusive of Andhra Pradesh Technology Service Limited. If no qualified and suitable person is available for promotion.
2. Associate Systems Analyst	(i) BY promotion from the post of programmer. (ii) By transfer on tenure basis of persons in equivalent or comparable rank in any department of Government undertaking inclusive of Andhra Pradesh Technology Service Limited., if no qualified and suitable person is available for promotion.

3. Programmer

- (i) By promotion from the post of Associate Programme in the Andhra Pradesh Police (Computer Centre) Subordinate Service
- (ii) By direct recruitment, if no qualified and suitable Associate programmer is available.
- (iii) By transfer on tenure basis of a person in equivalent or comparable rank in any department of State Government undertaking inclusive of Andhra Pradesh Technology Service Limited. If no qualified and suitable person is available for promotion or by direct recruitment.

Note: - In the matter of direct recruitment to posts for which men and women are equality suited, other things being equal, preference shall be given to women and they shall be selected to the extent of at least 30% of the posts in each category of OC, BC-A,B,C,SC &ST Quota.

4. Tenure:

The appointment on tenure basis to any post in the Services, shall not ordinarily be for more than three years at Subject to the maximum of five years.

Provided that nothing in this rule shall preclude the Government or the Director General of Police as the Case may be to repatriate the officers taken on tenure basis to their parent Department, before the expiry of the tenure period, if it is considered necessary, in public interest.

5. Qualification:

No person shall be eligible for appointment to the categories specified in column (1) of the annexure to these rules, by the method specified in column (2) unless he possesses the qualifications specified in the corresponding entry in column (3) thereof

6. Age:

No person shall be eligible for appointment by direct recruitment, if he had completed twenty eight years of age on the first day of July of the year in which the notification for selection is made.

7. Probation:

(a) Every person appointed by direct recruitment to any of the posts shall, be on probation for a total period of two years on duty within a continuous period of three years and every person appointed to any of the posts either by promotion or by transfer shall be on probation for a total period of one year on duty within continuous period of two years, from the date on which he commences probations.

8. Training

Every person appointed to the Categories (1) to (3) in Class, and all the Categories mentioned in Class-B, shall undergo all such trainings in the field of Computer Technology, as may be prescribed by Director General of Police/Government, from time to time.

9. Minimum Service:

No person shall be eligible for appointment by promotion unless, he had put in not less than six year of service, in the category from which promotion is made.

(iii) <u>Experience (Desirable):</u> (a) Must have working experience with the advance operating Systems like Unix (16/32 Bit Micro) and Operating System VMC VSI etc., (b) Must have experience in the Development of Software for applications: On LINE &REAL TIME SYSTEMS OR TRANSACTION PROCESSING SYSTEMS.

(i) Must possess a Master's Degree in Computer Applications or M.Tech Computer Science or post graduate Degree in Mathematics/Physics/Applied Physics/ Statistics/Electronics/Computer Science as one of the subjects from any recognized University in India established or incorporated by or under a central Act., provincial Act or a State Act or an Institution recognized by the

(i) Must possess a Master's Degree in computer Applications or M. Provincial Act or State Act or an Institution recognized by the University Grant Commission or an equivalent qualifications.

(ii) Experience (Essential)

Must have a minimum experience of three years in the following areas:

(a) Minimum experience of one years in System & Design.

(b) A record of specific experience to his credit in the Development of Application Software in any of the Computer Language COBAL, PASCAL, BASIC AND Language - C.

(c) Working experience in the development of Software for the applications in D-Base-III D-Base-IV, Relational Data Base Management System etc.,

Must possess a Master's Degree in Maths/Physics/ Statistics/ Computer Science as one of the subjects with one years experience in Computer Programming.

OR

Bachelor's Degree in Computer Science with one year experience in Computer Programming.

OR

Bachelor's Degree in any faculty Science with one year experience in Computer programming.

OR

Bachelor's Degree in any faculty having passed in Intermediate (vocational) with computer Science and with one year experience in computer programming

OR

Bachelor's Degree in any faculty other than oriental languages,

Fine Arts etc., preferably with Maths/ Physics as one of the subjects with a Diploma in Computer Sciences/ Software Technology with one year experience in Computer programming.

Bachelor's Degree in any faculty other than oriental languages, Fine Arts etc., preferably with Maths/ Physics as one of the subjects with 3 years experience in Computer Programming
