**ORDER:**

The Government have appointed the One Man Commission to take up comprehensive examination, revision and updating of the Service Rules for the various posts under the State Government. Accordingly One Man Commission took up the Special Rules for the Andhra Pradesh Police (Intelligence) Subordinate Service and forwarded them to Government for approval and issue.

2. The Government after careful examination of the draft rules prepared by the One Man Commission approve the same and issue the following Special Rules.

3. The following notification will be published in the Andhra Pradesh Gazettee:-

**NOTIFICATION**

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and of all other issued in G.O.Ms.No1271, G.A (Ser. A) Department, Dated the 17<sup>th</sup> October, 1966 as amended from time to time in so far as the posts mentioned in this service, the Governor of Andhra Pradesh hereby makes the following Special Rules for the Andhra Pradesh Police (Intelligence) Subordinate Service:

**SPECIAL RULES**

**1. Short Title:**

These rules may be called the Andhra Pradesh Police (Intelligence) Subordinate Service Rules.

## **2. Constitution:**

The service shall consist of the following categories of posts.

- Category (1) : Assistant Manager (Intelligence Branch)  
Category (2) : Intelligence Branch Assistant  
Category (3) : Photographer  
Category (4) : Assistant Photographer

## **3. Method of appointment:**

Subject to the other provisions in these rules, the method of appointment and appointing authority for the several categories shall be as specified in the table below:

<b>Category (1)</b>	<b>Method of appointment (2)</b>	<b>Appointment Authority (3)</b>
1. Assistant Manager (Intelligence Branch)	By promotion of Intelligence Branch Assistance	Deputy Inspector General, (Administration)
2. Intelligence Branch Assistant	(i) By appointment by transfer of personnel of the Ministerial service in the Police Department (ii) If no person is eligible or suitable for appointment by method (i) above by direct recruitment.	Deputy Inspector General, (Administration)
3. Photographer	By promotion of Assistant Photographer.	Deputy Inspector General (Administration)
4. Assistant Photographer	By direct recruitment.	Deputy Inspector General (Administration)

## **4. Reservation for appointment:**

The rule of special representation (General rules 22) and (General Rule 22-A) shall apply to appointments by direct recruitment to the post of Intelligence Branch Assistant and Assistant Photographer, provided that no reservation shall be made for physically handicapped persons.

## **5. Qualifications:**

No persons shall be eligible for appointment to the categories specified in column (1) of the Annexure to these rules by the method specified in column (2) unless he possesses the qualification specified in the corresponding entry in column(3) thereof.

## **6. Age:**

No person shall be eligible for appointment by direct recruitment, if he has completed 28 years of age on the first day of July of the year in which the notification for selection is made.

## **7. Minimum Service:**

No person shall be eligible for appointment by transfer or promotion unless he has put in not less than three years of service but in no case shall it be less than two years of service in the category from which promotion or appointment by transfer is made.

## **8. Probation:**

(a) Every person appointed by direct recruitment to the post shall, from the date on which he commences probation, be on probation for a total period of two years on duty within a continuous period of three years.

(b) Every person appointed to any of the posts either by promotion or by transfer shall, from the date on which he commences probation, be on probation for a total period of one year on duty within a continuous period of two years.

## **9. Transfers and Postings:**

Inspector General (Intelligence) shall be competent to effect the transfers and postings of persons in the respective categories.

1. Assistant Manager	By promotion	Must have passed the test in Andhra Pradesh Police Manual
2. Intelligence Branch Assistant	Appointment by transfer or by direct recruitment	(i) Must possess a Bachelor's degree of a University in India established or incorporated by under a central Act, Provincial Act or a State Act or an Institution recognized by the University Grants Commission or an equivalent qualification (ii) Must have passed Typewriting examination in English by lower grade conducted by the Andhra Pradesh State Board of Technical Education and training.
3. Photographer	BY promotion of Assistant Photographer	Must possess the qualifications prescribed to the post of Assistant Photographer.
4. Assistant Photographer	By direct recruitment	(a) (i) Must have passed S.S.C. or its equivalent examination of Government of Andhra Pradesh. (ii) Must possess a certificate in Photography from a recognized or reputed institution or any equivalent qualifications of must have 3 years experience at a Photographer in a reputed Institution or organization Must possess a diploma or a certificate in Photography or any recognized/ reputed Institution in India.  (b) The candidate should have studied Telugu at S.S.C., level or should pass a test conducted by the Department. (c) Must have certified to possess the visual standards specified below with glasses: (i) R. eye D.V. 6/6.M.V. 0.5 (Snelion) (ii) L. eye D.V. 6/6 M.V. 0.5 (Snelion) (iii) Each eye must have full field of vision colour blindness or any morbid conditions of the eye or lids of either eye
