**ORDER:**

In the G.O. 1<sup>st</sup> read above, orders were issued framing adhoc rules for the posts of Inspector in the then Central Stores Purchase Department, with different designations as Inspector (Mechanical)/Inspector (Electrical)/Inspector (Training)/Inspector (Chemical)/ Inspector (Medical)/Inspector (Textiles) and different Technical qualifications depending on the requirements of the department, subsequently, Commerce and Export Promotion Department has been constituted by bi-furecating the then Central Stores purchase Department. As the duties and responsibilities now attached to the post of Inspectors in Commerce and Export promotion Department do not requires any technical qualifications, it is felt necessary to adopt a common designation as Inspector. The Government have, accordingly, decided to change the various designations of Inspector as referred to in the G.O.1<sup>st</sup> read above, as a common designation of Inspector.

**NOTIFICATION**

In exercise of the powers conferred by the proviso to Articles 309 of the Constitution of India the Governor of Andhra Pradesh hereby makes the following Special Rules for the posts of Inspectors in Supercession of the orders issued in G.O.Ms.No.1456, Industries Department dated:20.11.1958 and also for the post of Librarian in the Andhra Pradesh Commerce and Export Promotion Department.

**Special Rules**

**1.Short title:**

The rules shall be called in Andhra Pradesh Commerce and Export Promotion on subordinate service Rules.

**2. Constitution:**

This service shall consist of the following categories of posts in the Commerce and Export promotion Department.

Category (1) : Inspection.

Category (2): Librarian.

### **3. Method of Appointment and Appointing Authority:**

The method of appointment and appointing authority for these two categories of posts shall be as follows:-

Category	Method of Appointment	Appointing Authority
1. Inspector	By recruitment by transfer from the category of Senior Assistants in the Commerce and Export Promotion Department.	Director of Commerce and Export Promotion.
2. Librarian	1) By recruitment by transfer from the category of Senior Assistants in the Commerce and Export Promotion Department.  II) If the qualified candidates in the category of Senior Assistants in the Commerce and Export Promotion Department are not available, by transfer, on tenure from the category of Assistant Librarian, Grade-I, from Public Librarian Department.	Director of Commerce and Export Promotion  Director of Commerce and Export Promotion

### **4. Qualifications**

No Senior Assistant in the Department shall be eligible for appointment by transfer to the post of Librarian unless he possesses a Degree in Arts/Commerce/Science from a recognised University and also a Diploma or certificate in Library from a recognised university or Institution.

### **5. Minimum Services:**

No Senior Assistant in the Department for appointment by transfer to the ----- date of commencement of probation, in the category of Senior Assistant.

### **6. Probation:**

Every person appointed to the posts in categories and 2, shall from the date on which he commences probation be on probation for a total period of one year on duty within a continuous period of two years.

### **7. Transfer and Postings:**

The Director of Commerce and Export promotion shall be competent to effect transfers and postings of persons covered by these rules.
