NOTIFICATION

In exercise of the powers conferred by the proviso to article 309 of the Constitution of India and in suppression of the Andhra Pradesh Cooperative subordinate Service Rule in so far as they relate to the posts included in this service the Governor of Andhra Pradesh hereby makes the following special rules for the posts in the Andhra Pradesh Sugar Subordinate Service

RULES

1. Short title

These rules may be called the A.P. Sugar Subordinate Service Rules.

2. Constitution:

The service shall consist of the following categories of posts in the AP. Sugar Subordinate Service.

- Category (1) : Cooperative Sub Registrar
Category (2) : Senior Inspector
Category (3) : Junior Inspector
Category (4) : Additional Assistant Engineer.
Category (5) : Statistical Assistant (including Section Officer)
Category (6) : Computers

3. Method of appointment and appointing authority:

Subject to the other provisions in these rules the method of appointment and appointing authority for the

Several categories shall be as follows:-

Category	Method of appointment	Appointing authority
1. Cooperative Sub Registrar	No future appointment	
2. Senior Inspector	No future appointment	Director of Sugar
3. Junior Inspector	No future appointment	
4. Additional Assistant Engineer.	By transfer on tenure of an Assistant Engineer of the R & B Department	Director of Sugar

5. Statistical Assistant(including Section Officer)	By transfer on tenure of a Deputy Statistical officer of the Directorate of Economic and Statistics	Director of Sugar
6. Computers	By transfer on tenure of a Statistician of the Directorate of Economic and Statistics	Director of Sugar

Note: 1. The Senior Inspectors, Junior Inspectors of Cooperative Societies will be eligible and will be considered for appointment to the post of Superintendents in the Sugar Department by including the names of Senior Inspectors of Cooperative Societies, Junior Inspectors of a Cooperative Societies with reference tot their dates of appointment to the posts of junior Inspectors of Cooperative Societies computer in the seniority list of senior Assistants of the Department. As and when these posts of senior Inspectors and Junior Inspectors are vacated for any reason, the posts will be converted to those of Senior Assistants.

2. The Cooperative Sub Registrars will be eligible and will be considered for appointment to the post of Assistant Director (Sugar) along with Superintendents of the Department. As and when these posts of Cooperative Sub-Registrars are vacated for any reason, the posts will be converted as superintendents in the Andhra Pradesh ministerial Service Rules.

3. The persons in the feeder Categories for promotion to the posts of superintendents shall pass Departmental test covering among other things, sugarcane laws and Cooperative Laws when it is prescribed in due course and pending the prescription of such a departmental test, they shall be required to pass the following tests for being eligible for promotion as Superintendent:-

1.Senior Inspectors and Junior Inspectors	Agricultural Department test
2. Senior Assistants	Agricultural Department test of the examination in Cooperation, Auditing, Banking and book keeping conducted by the Central Cooperative Institute, Hyderabad
3.Junior Assistants Senior Assistants	Account tests part I for Subordinate officers.

4. Period of Tenure:

The persons appointed from other Departments, on tenure, shall be retained in the Department for not more than three years at a time.

Provided that the appointing authority or the Government is not precluded from repatriating the person before the expiry of the period of tenure

5. Transfers and Postings:

The Director of Sugar shall be competent to effect transfers and postings of the Personnel in this service.
